On May 19, the Network held a webinar, "*Traceability: Where Are We and What's Next.*" This webinar featured a panel discussion on Traceability from the customer's perspective, including a food manufacturer, a policy expert, and an OEM packaging manufacturer on the panel. Technology Network Update

For 2021, the Technology Network focused its energies on remote access challenges for data sharing and maintenance while ensuring secure plant operations. In the summer, it published a Technote titled, "Bridging the Information Gap with Secure Remote Access." This topic was discussed during the 2021 PROCESS EXPO University panel titled, "Privacy, Security, the Cloud, and COVID: The Benefits of IIOT for your Company." The topic will be further addressed during the 2022 FPSA Annual Conference (March 22-24), with a two-day panel discussion on cybersecurity and IIOT. For 2022, the Network is establishing a working group to further address this vital topic. For those considering participating in this group, here are some details you need to know:

How will a person benefit from being involved in this small working group?

A: You will become a subject matter expert on various vital topics the industry currently faces, building exposure for you and creating the opportunity for new business leads.

What is the objective/goal(s) of the working group?

- **A:** Developing resources for customer conversations
 - Getting remote access buy-in from customers' IT Depts on the data sharing front
 - · Learning from others about how this topic has impacted others' businesses and sharing potential solutions

What kind of time commitment will it take to participate in the working group?

A: An hour every three weeks.

How many people and what type of professional backgrounds do we need for the group?

- A: Four Five people
 - OEMs, Integrators, End Users, Equipment Providers
 - Technical background for 1 -2 members, also someone from the operational level

What does this group hope to give back to the Association?

A: Provide information to the other councils/networks on how to address this topic for the greater good of the membership

What is the duration of this project?

A: Six months

What is the ROI for my company?

A: You can add the developed resources to your sales toolbox. You've countered these challenges, and you have resources that you can lean on, and it might help you get the second conversation with the customer.
